Oscar Ticket Drawing Rules

1. Eligibility

Persons without internet access at home may enter The Drawing at Linganore High School during their regularly scheduled lunch shift. Those people may visit Lancer Media in room A206 (lunch shifts 1, 2, and 4) or C203 (lunch shift 3), to submit the online form.

Limit one (1) entry per person, per email address for the duration of the Contest Period, regardless of method of entry. Entries received from any person or email address in excess of the stated limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned.

Entries that are incomplete, illegible, fraudulent or corrupted are void and will not be accepted.

6. Prize Drawing

On or about February 25, 2015, the Sponsor will select potential winners from among all eligible entries received. Entries will be compared to the results from The 2015 Oscar Awards, and the number of correct guesses will be counted for each person. The entrant with the highest number of correct guesses will become The Winner. If there are multiple potential winners, The Sponsor will select one Winner in a random drawing. The Sponsor will attempt to notify the potential winner in person, via telephone, or by email on or about February 25, 2015.
